- Free transactions per month on HDFC Bank and Non- HDFC Bank ATMs in India - as approved for main salary account
- Free Times Points Debit Card with ATM cash withdrawal limit of Rs 1,00,000 per day and POS usage limit of Rs.2,75,000 per day
- Free Personal Accidental Death Cover of Rs. 1 lakh on the account
- Free Personal Air Accidental Death Cover of Rs.5 lakhs on the account
